Record-Breaking Capital Credit Refund Approved

The Albemarle EMC Board of Directors has approved the largest capital credit refund in the history of the co-op.

In an effort to reach the members that have been with us the longest as well as those that are among the newest, the cooperative returned 100% of the remaining margins from 1994, 40% of the margins allocated in 1995 and 4 percent of the margins allocated in 2018, totaling \$606,525.92.

If you were a member of Albemarle EMC during these years, you will receive your capital credits refund in April in the form of a credit on your electric bill. If a member has several accounts, the capital credit system added them together, with

the credit posting only on one account. Anyone who received power during the years shown, but is no longer an active member will receive their refund by check. This is why it is so important for you to give us a good forwarding address when you move off our lines.

Capital credits are year-end margins earned by your cooperative, which are allocated to members based on usage.

“For the second year in a row, your cooperative will refund the most capital credits in our history,” said Gary Ray, general manager of Albemarle EMC. “This is a big part of what it means to be an electric cooperative member.”

ACT Grant Assists Water Rescue

Perquimans County Emergency Management recently received a \$2,000 Albemarle Community Trust grant that will be used to purchase a 5 h.p. Honda outboard motor for their water rescue boat.

Emergency Management Coordinator Jarvis Winslow said the boat has been used during flooding events to evacuate residents from their homes.

“The boat has been powered by an electric trolling motor, but the battery would not last long enough,” he said.

The Albemarle Community Trust is funded by Albemarle EMC members who contribute voluntarily through their power bills.

AEMC is Environmentally Friendly

As an avid hunter, I recognized early on the role that power line right of ways play in creating beneficial habitat for wildlife. These right of ways create what wildlife biologists refer to as early successional habitat. Trees are intentionally kept from growing tall in right of ways, which provides ample sunlight for beneficial vegetation such as honeysuckle, blackberries, warm-season grasses and more. Right of ways become akin to a home cooked buffet for deer, turkeys, rabbits, quail and nongame animals. Much of our area's woodlands have been converted to pine plantation that offers very little sustenance for wildlife. Power line right of ways that bisect these large pine plantations provide essential nutrition for wildlife. Did power companies, such as Albemarle EMC, set out to create miles and miles of wildlife habitat? No. The right of ways were created to provide reliable power transmission. Even so, the byproduct of maintaining power line right of ways helps wildlife and provides needed ecological diversity. In my book, that's still worthy of recognition.

This year marks the 50th anniversary of Earth Day, which was first celebrated on April 22, 1970 and serves as an annual recognition of the importance of protecting our planet and its resources.

At Albemarle EMC, we are committed to delivering power that is affordable, reliable and low carbon. More than half of our power comes from emissions-free nuclear, and we are increasingly incorporating renewable energy sources and grid-optimizing technologies to take this commitment even further.

As a co-op member, you can help amplify the benefits of electricity by using it as a cleaner, cheaper and smarter alternative to fossil fuels. Appliances, equipment, agricultural and industrial processes, and even your car, can now be powered by electricity, resulting in cost savings, lower emissions and increased productivity and efficiency.

Albemarle EMC recently installed its first electric vehicle charging station at the Hampton Inn, in Edenton (see article, page 25). Electric cooperatives are building a statewide electric vehicle charging network and implementing other innovative initiatives that support increased commerce, tourism and economic development in the communities

Your co-op also recently switched all member outdoor security lights to high efficiency LED. The new security light is 48 watts and replaces the 100-watt high pressure sodium and the 175-watt mercury vapor security lights.

Albemarle EMC is environmentally minded in several other aspects of its business as well. Several years ago, your cooperative switched all of its older mechanical meters to smart meters that are ready automatically. In addition to being a smart business move, automated meters provide environmental benefits. The technology eliminated the need for meter readers, who used to drive from house to house physically reading each meter. The automated meters also enable members to monitor their electricity usage on an hourly, daily or monthly basis through the cooperative's web portal. The information enables members to spot unusually high usage at their home and more quickly take corrective action. The system also automatically notifies cooperative employees when exceptionally high usage occurs so members can be notified.

Members can have the option of receiving their bills electronically, which reduces the amount of paper products entering the waist-stream. The co-op also offers used utility poles free of charge to the general public. Though no longer satisfactory for utility use, these poles are often good enough for other uses such as construction of pole barns. If these utility poles were not reused, they would be destined for a landfill.

Energy audits are offered to members at no charge. These audits evaluate heating and air systems, water heaters, air leaks around windows and doors, insulation levels and more. Efficient use of power lessens our overall impact on the planet. To schedule an audit, simply call (252) 426-5735.
